

TERMS & CONDITIONS

1. The Challenge is open to adults 18 years of age and over that are current Aquafit members and/or local community members.
2. The challenge commences on Monday 11 February and concludes Thursday 11 April 2019. Employees of Campbelltown Catholic Club are not eligible for prizes.
3. The Challenge is a partnership between Aquafit and "Metabolic Jumpstart". All participants will be required to establish a separate account with Metabolic Jumpstart, to provide online access to nutritional plans, recipes, support and coaching. All participants will be required to agree to the separately provided Terms and Conditions for Metabolic Jumpstart.
4. To Register you must complete the Registration form. The entry form details required include your name, address, e-mail address, phone number and DOB. If you are not a current member, a pre-exercise screening questionnaire must be completed.
5. The Registration fee is \$149 per person (Aquafit Member) and \$249 (Non Aquafit Member) and is payable on or before Thursday 7 February 2019. This fee is non-refundable. This fee entitles you to be eligible for:
